APPROVE ENGINEER FOR CDBG GRANT

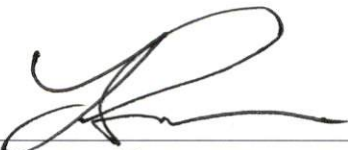
Mr. Lloyd discussed the request for qualified engineers for the CDBG FY2023 project for street paving and drainage improvements.

ADJOURN:

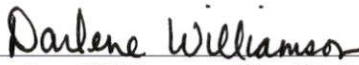
Mr. Rob Roberson made a motion to adjourn. Mr. Bruce Young seconded the motion and it passed by unanimous vote.
